Mr. President of the Argentinian Republic

Dr. Carlos Menem:

Mister President, I address you with the utmost respect to inform you of the processes I have been undertaking for the last 23 years.

On August 22 of 1972, my husband, Rubén Pedro Bonet, was killed by the Argentinian Navy.

I find that an explanation or a reminder of what occurred in the Argentinian base is unnecessary.

I end this letter with the slogan that was written and shouted in the entire country as from the own August 22 of 1972.

Neither forget nor forgive!

Please receive my respectful greetings, and my appreciation on behalf of my children and of all family members of Trelew for any measure you might take to serve justice.
