I. INTRODUCTION AND BACKGROUND

A. Introduction

- 1. My name is Claudio Grossman. I am Professor of Law and Dean Emeritus of the American University Washington College of Law and a specialist in public international law and international human rights law. My qualifications, basis for expertise, and summary of opinions are set forth in greater detail below.
- I have been retained as an expert witness by Plaintiff Obada Mzaik in *Mzaik v. Syrian Arab Republic*, Case No. 1:22-cv-00042-ACR, to provide my expert opinion on: (a) whether Mr. Mzaik's maltreatment by security forces of the Syrian Arab Republic (*Syria*) constituted torture under the Convention against Torture and other Cruel, Inhuman or Degrading Treatment or Punishment (the *CAT*) and (b) if so, the nature of the reparations due to Mr. Mzaik under international law.
- 3. I offer the following expert report containing my statement of expected testimony, the reasons for this testimony, and any data or other information and materials considered in forming my expert opinion and testimony.

B. Qualifications

- 4. I am Professor of Law and Dean Emeritus of the American University Washington College of Law, where I have taught since 1983. My *curriculum vitae*, which includes a complete list of my publications and presentations, is attached as **Exhibit A**.
- 5. Throughout my career, I have promoted the rule of law and human rights through my contributions to academia and international and domestic organizations and have participated in landmark cases in regional and international courts and mechanisms, including before the International Court of Justice.
- 6. I currently serve as a member of the United Nations International Law Commission, which is a body of experts responsible for helping develop and codify international law. The Commission is composed of 34 individuals who are elected by the United Nations General Assembly every five years. I was first elected to the Commission in 2016 and was reelected in 2021. In 2023, I was appointed Special Rapporteur on Immunity of State Officials from Foreign Criminal Jurisdiction by the Commission. In this role, I am tasked with preparing a report for discussion by the Commission to be submitted to the UN General Assembly. In 2024, I presented my first report as Special Rapporteur to the Commission.

- 7. I previously served as a member (2003-2015) and the chairperson (2008-2015) of the United Nations Committee against Torture, which is the body of independent experts that monitors the implementation of the CAT. As a member of the Committee against Torture, I helped: (a) examine States' reports about their implementation of the CAT and formulate recommendations to States in the form of "concluding observations," (b) consider complaints or communications from individuals claiming that their rights under the CAT had been violated, and (c) draft "general comments" that set out the Committee's interpretation of certain provisions of the CAT. Notably, I proposed and participated in the drafting and adoption of General Comment No. 3, which explained and clarified States' obligations with respect to reparations under the CAT.
- 8. While I was chairperson of the United Nations Committee against Torture, I presided over the Committee's consideration of the situation in Syria.
- 9. Prior to my service on the Committee against Torture, I served on the Inter-American Commission of Human Rights from 1993 to 2001, where I was President, Special Rapporteur on the Rights of Women, and Special Rapporteur on the Rights of Indigenous Populations.
- 10. In March 2023, I was elected as Vice-President of the Committee of Admissibility of Chile's new constitution.
- 11. In 2019, I was elected to the Institut de Droit International (Institute of International Law), whose membership comprises the world's leading public international lawyers. In 2020, I was awarded the Goler T. Butcher Medal by the American Society of International Law for "outstanding contributions to the development and effective realization of international human rights." In January 2025, I will receive the Nelson Mandela Award for my exceptional contribution to international human rights from the Association of American Law Schools.
- 12. I have lectured and written extensively on issues relating to human rights, the CAT, and reparations under international law. My publications are listed in my *curriculum vitae* contained in Exhibit A and include:

- 13. I received my law degree (Licenciado en Ciencias Jurídicas y Sociales) from the University of Chile Law School, Santiago in 1971 and a doctorate in legal studies (Doctor in de Rechtsgeleerdheid) from the University of Amsterdam in 1980.

C. Compensation

14. I am not being compensated for this report or for my expert testimony. I will be reimbursed for reasonable expenses incurred while fulfilling my role as an expert. My opinion is not conditioned upon any payment.

D. Evidentiary Basis for Opinion

15. In preparing this report, I relied on my personal knowledge, expertise, and research on the CAT, international law on reparations, and the human rights situation in Syria.

- 16. I additionally relied on legal research that I conducted when drafting my publications, as well as the jurisprudence of the Committee against Torture and other international and regional bodies.
- 17. To better understand the situation in detention centers in Syria, I relied on reports from research institutions, non-governmental organizations, and other United Nations bodies, including the Independent International Commission of Inquiry on the Syrian Arab Republic. I also examined documents in the above-captioned case, including the Complaint and witness declarations.
- 18. A list of the materials that I reviewed and/or relied on to prepare this report is attached hereto as **Exhibit B**. I will supplement this expert report, to the extent necessary, based on the filing of additional relevant materials in this case.

II. SUMMARY OF FINDINGS

- 19. First, I was asked whether Mr. Mzaik's maltreatment by Syria's security forces constituted torture under the CAT. Based on the facts alleged in Mr. Mzaik's declaration as well as the Complaint (which I have been asked to assume are true and correct), and their consistency with documented detention and torture practices of Syria, I conclude that Mr. Mzaik's maltreatment constituted torture in violation of the CAT. Syrian officials, including from the Air Force Intelligence (*AFI*), inflicted on Mr. Mzaik acts of severe pain and suffering (both physical and mental) that individually and cumulatively amounted to torture under the CAT while he was held in detention by the AFI at the Mezzeh Military Airport. Such acts included repeated beatings with hands, kicks, and pipes; violent threats; forcible witnessing of the torture of other detainees (including his cousin); and unsanitary detention conditions. Syrian officials inflicted these acts for proscribed purposes such as extracting information, false confessions, and punishing Mr. Mzaik for his alleged involvement in anti-regime activities.
- 20. *Second*, I was asked to opine on the scope and nature of reparations due to Mr. Mzaik as a torture victim under the CAT and international law generally. Under the CAT and international law, Mr. Mzaik would be entitled to "full and effective redress" that is holistic and victim-oriented and therefore considers his individual needs and circumstances. Full and effective redress includes compensation for any economically assessable harm, whether pecuniary or non-pecuniary, including long-term harm caused by the torture he endured. Further, this Court's judicial determinations on the facts of Mr. Mzaik's case may be a critical piece of his right to truth and redress.

III. FINDINGS

21. This report proceeds in two parts. In Section A, I conclude that Syria's maltreatment of Mr. Mzaik (as described in his declaration and the Complaint) constitutes torture under Article 1 of the CAT. In Section B, I discuss the scope and nature of reparations due to Mr. Mzaik as a torture victim under the CAT and international law generally. I particularly highlight that the "full and effective redress" to which Mr. Mzaik would be entitled requires a holistic and victim-oriented approach.

A. SYRIA'S MALTREATMENT OF MR. MZAIK CONSTITUTES TORTURE IN BREACH OF THE CAT

22. Article 1 of the CAT defines "torture" as:

any act by which severe pain or suffering, whether physical or mental, is intentionally inflicted on a person for such purposes as obtaining from him or a third person information or a confession, punishing him for an act he or a third person has committed or is suspected of having committed, or intimidating or coercing him or a third person, or for any reason based on discrimination of any kind, when such pain or suffering is inflicted by or at the instigation of or with the consent or acquiescence by a public official or other person acting in an official capacity.¹

- 23. Thus, broadly speaking, "torture" has three elements: (1) an act causing "severe pain or suffering"; (2) a proscribed purpose for which the act is "intentionally inflicted"; and (3) the infliction of the act at the hands of a public official or other person acting in an official capacity.
- 24. As detailed below, given the facts alleged in Mr. Mzaik's declaration, the Complaint (which I have been instructed to assume to be true and correct), and available documentation about Syria's torture and detention practices, Syria's maltreatment of Mr. Mzaik squarely satisfies each of these three elements and therefore constitutes torture under the CAT.
- 25. In my analysis, I rely primarily on the interpretation and application of the CAT by the Committee against Torture. However, the CAT's definition either guides the interpretation of the term "torture" or is similar to the definition of the term "torture" in other international or regional treaties, including the International Covenant on Civil and Political Rights, the

Inter-American Convention against Torture, and the European Convention on Human Rights. Therefore, interpretations and applications by the relevant treaty and judicial bodies of what constitutes "torture" under such other international and regional treaties provide useful guidance. Accordingly, where relevant, I draw on such interpretations and applications in my analysis.

1) Acts of Severe Pain or Suffering

26. Based on the facts in the Complaint, Mr. Mzaik was subjected to several acts of "severe pain and suffering." Many acts involved both "physical" and "mental" components, and it is therefore necessarily imprecise to categorize these acts of pain and suffering as either "physical" or "mental." Nonetheless, for the sake of analysis, I have divided the acts of pain or suffering inflicted on Mr. Mzaik into three categories: (a) acts of physical pain or suffering, (b) acts of mental pain or suffering, and (c) conditions of detention causing severe pain or suffering. These acts—independently and cumulatively—meet the severity requirement of torture under the CAT.

a. Acts of physical pain and suffering

- 27. The acts of physical pain or suffering inflicted on Mr. Mzaik are consistent with welldocumented torture methods used by Syrian officials at detention centers and meet the severity requirement of torture under the CAT.
- 28. For example, Syrian officials slapped, beat, kicked, and strangled Mr. Mzaik upon his arrival at the Mezzeh Military Airport complex, and punched him in the face hundreds of times and pummeled him with kicks during his time in detention.²
- 29. Numerous human rights organizations have documented Syria's systematic use of acts, such as those suffered by Mr. Mzaik, to torture detainees at detention centers:
 - a. In a 2011 report, the United Nations Independent International Commission of Inquiry on the Syrian Arab Republic (*UN Syria Commission of Inquiry*) described the acts inflicted on Mr. Mzaik as commonplace. The report found, based on interviews conducted with survivors, that many detainees were "subjected to severe beatings with batons and cables" and that torture was "rampant" at the AFI detention facility at Mezzeh.³

- b. In a subsequent report in 2013, the UN Syria Commission of Inquiry noted that "[r]eported methods of torture remained consistent across the country" and survivors described, among other things, being "kicked."⁴
- c. In a 2021 report, the UN Syria Commission of Inquiry listed "severe beating with various tools" as one of at least 20 widely documented torture techniques used by Syrian officials.⁵
- d. At a UN Security Council briefing in November 2016, then-US Ambassador to the UN Samantha Power specifically named the AFI branch in the Mezzeh Military Airport, where Mr. Mzaik was detained, as a location where "torture has taken place and where it continues to take place."⁶
- e. Likewise, a 2019 report by the Syrian Network of Human Rights (*SNHR*), a nongovernmental organization that briefs the United Nations on human rights violations in Syria, identified "beating" as one of 39 documented methods of "physical torture" systematically practiced by Syrian officials against detainees in detention centers.⁷ Drawing on interviews with thousands of people who have survived detention and torture in Syria's detention centers (including at the hands

of the AFI), the SNHR concluded that Syrian officials practiced the torture method of "beating" "on a continuous basis as part of all the methods and positions of torture used."⁸

- f. Moreover, Human Rights Watch has documented Syria's use of "torture methods" including "prolonged and severe beating, punching, kicking," and "beating with objects ([including] cables, whips, sticks, batons, [and] pipes)," based on interviews with over 200 former detainees and defectors from the Syrian military and intelligence agencies.⁹
- 30. The beatings, kicking, and choking Mr. Mzaik suffered are "severe" enough to constitute "torture" under the CAT. The Committee against Torture and other United Nations bodies have repeatedly held that continuously kicking and punching a detainee, beating them with bars or sticks, and strangling them "constitutes torture within the meaning of article 1 of the Convention [Against Torture]."¹⁰ For example, in *Ali v. Tunisia*, the Committee found that being repeatedly punched, kicked, and otherwise beaten constituted torture under the CAT.¹¹ Similarly, in *Yakubova v. Uzbekistan*, the United Nations Human Rights Committee found that continual beatings and strangulation by prison authorities amounted to torture under Article 7 of the International Covenant on Civil and Political Rights.¹²

31. Syrian officials beat Mr. Mzaik with a PVC pipe on his palms and the soles of his feet until he could no longer stand.¹³ Beating on the soles of the feet, which is termed "*falaqa*" or "*falqa*," is a common and rampant method of torture used by Syrian officials.¹⁴ The UN Syria Commission of Inquiry has received multiple reports of detainees being subjected to *falqa* at Syrian detention facilities.¹⁵ In *Laaroussi v. Morocco*, the Committee against Torture specifically found that being beaten on the soles of his feet with an iron bar—similar to the *falqa* inflicted on Mr. Mzaik—constituted torture.¹⁶

b. Acts of mental pain and suffering

- 32. The United Nations Special Rapporteur on torture and other cruel, inhuman, or degrading treatment or punishment (the *Special Rapporteur on Torture*) has defined "psychological torture" to include "all methods, techniques and circumstances which are intended or designed to purposefully inflict severe mental pain or suffering without using the conduit or effect of severe physical pain or suffering."¹⁷ The Special Rapporteur on Torture has explained that perpetrators typically use specific psychological torture methods in combination with other methods and circumstances, creating a "torturing environment."¹⁸ As detailed below, Mr. Mzaik was subjected to several acts that would constitute psychological torture.
- 33. *First*, Mr. Mzaik was repeatedly threatened with physical violence, including beatings, electrocution, and being hung by his wrists all night in positions causing extreme pain, while being accused of being a "Zionist."¹⁹ Threats against detainees and their relatives is a pervasive torture method used at Syrian detention centers. For example, a report by Human Rights Watch based on more than 200 interviews with former detainees noted that

"[a]ll" of the interviewees "said the interrogators verbally and physically humiliated them, and threatened both them and their relatives with further abuse or, in some cases, execution."²⁰ SNHR also identified threats to relatives or threats of execution, and insults or humiliation as among the techniques of psychological torture used at Syrian detention centers.²¹

34. The Committee against Torture has recognized that "threats, including death threats . . . constitute torture as defined in Article 1 of the Convention."²² Moreover, Special Rapporteur mandate holders,²³ the Committee against Torture,²⁴ and the United Nations Human Rights Committee²⁵ have noted that direct or indirect threats of inflicting, repeating or escalating acts of torture constitute the intentional infliction of fear, which itself amounts to torture. The Inter-American Court of Human Rights has also noted that "threats and real danger of physical harm causes . . . such a degree of moral anguish that it may be considered

psychological torture."²⁶ For example, the Inter-American Court found that threats by police officers of physical torture and killings of a victim and their family members amounted to psychological torture.²⁷

35. Second, Mr. Mzaik was forced to witness the torture of other detainees, including his cousin, and threatened with the same treatment.²⁸ For example, a guard hung Mr. Mzaik's cousin by his already brutalized wrists outside the interrogation room where Mr. Mzaik was being interrogated.²⁹ The interrogator forced Mr. Mzaik to listen to his cousin being tortured and threatened that Mr. Mzaik would also be hung by his wrists and electrocuted unless he confessed.³⁰ Mr. Mzaik has not seen his cousin since that interrogation.³¹ Mr. Mzaik was also forced to listen to the torture of other detainees.³² On one occasion, Mr. Mzaik heard an interrogator order a guard to hang a detainee by his wrists from the ceiling. Whenever the detainee fell, he was strung up again. Mr. Mzaik heard the detainee pleading for the interrogator to stop and the interrogator ordering the guard to stuff the detainee's mouth with salt before covering it with a cloth. Mr. Mzaik then heard the detainee's cries as the interrogator poured scalding water over the detainee.³³ On another occasion, Mr. Mzaik heard a boy being interrogated and pleading for the guards to stop. He heard the guards whip the boy as he called out for his mother.³⁴ Reports by non-governmental organizations corroborate that Syrian officials commonly forced detainees to witness the torture of relatives or other detainees in Syrian detention facilities.³⁵

- 36. The United Nations Human Rights Committee has held that witnessing a family member being tortured leads to severe mental pain and suffering, amounting to torture.³⁶ The Special Rapporteur on Torture has also found that witnessing the torture of other detainees, in combination with the continuous threats of torture, creates a "torturing environment" that amounts to psychological torture.³⁷ For example, the Special Rapporteur on Torture found "credible" allegations of physical and psychological torture in situations similar to those faced by Mr. Mzaik, where Ukrainian detainees in Russian detention facilities were being forced to watch other detainees being beaten while hung by their arms and could hear women screaming and crying.³⁸
- 37. *Third*, Mr. Mzaik was subjected to violations of his privacy, including being stripped naked or to his underwear and searched.³⁹ Many human rights organizations have identified forced nudity as one of the torture methods commonly used at Syrian detention centers.⁴⁰
- 38. The Special Rapporteur on Torture has noted that subjugation, which can be achieved through privacy violations like strip searches, forms a "torturing environment" when combined with other factors.⁴¹ The Committee against Torture has similarly described being "subjected to a body cavity search (oral and naked) while completely naked" as an "act[] of torture."⁴² It has also found that being "stripped to [one's] underwear"—in addition to being beaten with a police club for an hour while handcuffed to a wall, and

being denied food and water, medical attention, and the possibility of using a lavatory for three days while in detention—amounted to torture under the CAT.⁴³ Syrian officials stripped Mr. Mzaik naked or to his underwear and searched him, in addition to subjecting him to other acts of mental and physical pain and suffering such as beatings (as described above) and deplorable detention conditions such as being denied food, not allowed to shower, and given only 30 seconds to use the restroom (as described below). Consistent with the findings of the Committee against Torture, being stripped naked or to his underwear and searched formed part of the acts of torture or torturing environment inflicted on Mr. Mzaik.

c. Conditions of detention causing severe pain or suffering

- 39. Mr. Mzaik was detained in unheated, overcrowded cells that were (a) too small for detainees to lie down flat at the same time, forcing them to sleep on their sides, pushed up one against the other, (b) filled with ticks, lice, and other insects, which caused painful bites and skin rashes, and (c) without any blankets, despite the frigid winter temperatures.⁴⁴ Mr. Mzaik and other detainees were also deprived of food, forced to share one cup of drinking water among all cellmates, not allowed to shower, given only 30 seconds to use the restroom, and forced to strip before using the restroom.⁴⁵ Mr. Mzaik was also denied medical care, and after he was released from detention, doctors diagnosed him as having contracted hepatitis from the unsanitary detention conditions.⁴⁶
- 40. The UN Syria Commission of Inquiry concluded that Syria held most detainees, like Mr. Mzaik, in "inhumane conditions which amount to ill-treatment, and may in some cases amount to torture."⁴⁷ It extensively documented conditions such as "severely overcrowded cells, lack of food, drinking water and sanitary facilities, widespread illness and diseases, and denial of medical care."⁴⁸

- 41. Similarly, a psychiatric study published in the leading journal BMC Psychiatry based on interviews with former detainees found that "[a]ll survivors" of Syrian detention facilities interviewed had been exposed to "extreme starvation, overcrowding, sleep deprivation, denial of medical care, dreadful sanitation and hygiene conditions, chronic darkness, lack of ventilation, denial of clothing, exposure to sounds of others being tortured, and extreme weather and temperature conditions" and posited that these conditions were "by itself a mode of torture."⁴⁹
- 42. The Committee against Torture has held that detention conditions, such as those suffered by Mr. Mzaik, may constitute torture. For example, the Committee has explained that overcrowding and other poor detention conditions, and particularly the lack of hygiene, adequate food and appropriate medical care, may amount to torture.⁵⁰ In *N.N. v. Burundi*, the Committee found that State party violated its Article 11 obligations to prevent torture of those in detention where the victim was subjected to "deplorable conditions," "food was insufficient and of poor quality," the prison was "overcrowd[ed]," and "conducive to the spread of diseases."⁵¹ Likewise, in *A.N. v. Burundi*, the Committee found that being "deprived of [medical] care, subjected to prison overcrowding and forced to sleep on the floor … were forms of treatment constituting torture."⁵² Similarly, in its Summary Account of the Results of the Proceedings Concerning the Inquiry on Turkey, the Committee against Torture found that being confined to "cells measur[ing] approximately 60 by 80 centimetres, [with] no light and inadequate ventilation, and [where] the inmate can only stand or crouch," "in themselves constitute a kind of torture."⁵³

2) Proscribed Purposes

43. Based on the facts in the Complaint, Syrian officials inflicted the above-described acts of pain and suffering on Mr. Mzaik for multiple purposes proscribed by Article 1 of the CAT.

- 44. *First*, Syrian officials inflicted these acts for the purpose of "obtaining . . . information or a confession."⁵⁴ They attempted to extract information about Mr. Mzaik's family and friends, as well as his contacts with a foreign government.⁵⁵ They forced him to falsely confess to supposed anti-regime activities, beating him more severely when he refused, including on one occasion forcing him to sign a "confession" while blindfolded.⁵⁶
- 45. Reports by the United Nations and human rights organizations document the widespread use of torture to elicit confessions or extract names of other persons at Syrian detention facilities.⁵⁷ For example, the UN Syria Commission of Inquiry found that "[d]etainees [at Syrian detention facilities] were routinely tortured to extract confessions or forced to sign or fingerprint declarations that they were not been allowed to read."⁵⁸ Similarly, Human Rights Watch found that interrogators and officers tortured detainees during interrogation sessions to force the detainees "to confess to having participated in demonstrations, provide names of other demonstrators and organizers, admit to owning and having used weapons, and in some cases provide information about alleged funding of demonstrations from abroad."⁵⁹
- 46. *Second*, Syrian officials perpetrated these acts for the purpose of "punishing" Mr. Mzaik for anti-regime acts that they "suspected" he had committed.⁶⁰ Syrian officials called Mzaik a "Zionist traitor" and made false accusations regarding Mzaik's anti-regime activities.⁶¹ The UN Syria Commission of Inquiry found that torture, amongst other detention-related violations, was used by the Syrian officials "to intimidate and punish."⁶² Similarly, Amnesty International reported that torture, including beatings, was used at Syrian military

prisons as a "regular form of punishment and degradation," in addition to being used to extract false confessions.⁶³ Detainees interviewed by Human Rights Watch further reported that they believed that the main reason they were being tortured "was not just to obtain information, but to punish and intimidate the detainees."⁶⁴

47. *Third*, Syrian officials sought to intimidate or coerce Mr. Mzaik. They subjected Mr. Mzaik to relentless threats, false information, and psychological abuse to intimidate him and coerce him to give them information about his friends and contacts with foreign governments.⁶⁵ As noted in the previous paragraph, the United Nations and human rights organizations have documented the common use of torture to intimidate detainees at Syrian detention centers.⁶⁶

3) Responsibility of Public Officials

- 48. The severe acts of pain and suffering were "inflicted by or at the instigation of or with the consent or acquiescence by a public official or other person acting in an official capacity."⁶⁷ As described in the Complaint, officials from the Air Force Intelligence Directorate—a branch of the Syrian government—directly inflicted these acts on Mr. Mzaik.⁶⁸
- 49. Moreover, the acts described by Mr. Mzaik are consistent with documented practices of the Syrian government around the time of and since Mr. Mzaik's detention, further corroborating the responsibility of Syrian public officials.⁶⁹ For example, in its 2012 Concluding Observations on Syria, the Committee against Torture expressed concerns about Syria's "[w]idespread use of torture and cruel and inhuman treatment of detainees, individuals suspected of having participated in demonstrations . . ." and the "[h]abitual use of torture and cruel and inhuman treatment as a tool, which appears to be deliberate and

part of State's policy, to instil fear and to intimidate and terrorize [the] civilian population."70

- 50. More recently, in 2021, the UN Syria Commission of Inquiry published a report extensively documenting Syria's arbitrary detention and imprisonment practices.⁷¹ Notably, the report concluded that "[a]ll parts of the Syrian security forces," including the Air Force Intelligence Directorate, inflicted "torture and ill-treatment against detainees" as a "systematic" matter and "involved high-raking officers."⁷² In its November 2023 provisional measures order, the International Court of Justice credited these and other reports by the UN Syria Commission of Inquiry documenting the continuing use of torture against persons in detention by the Syrian government, including by its intelligence forces.⁷³
- 51. The above-mentioned sources establish the existence of a consistent pattern of torture and mass violations of human rights inflicted by Syrian government officials in detention facilities. It may therefore be reasonably inferred that an individual case—like Mr. Mzaik's—followed the same pattern of torture by the Syrian government.

* * *

52. For the reasons detailed above, I conclude that Syria's maltreatment of Mr. Mzaik, as described in the Complaint, satisfies all three elements of "torture" under Article 1 of the CAT: (1) an act causing "severe pain or suffering"; (2) a proscribed purpose for which the act is "intentionally inflicted"; and (3) the infliction of the act at the hands of a public official or other person acting in an official capacity.

B. MR. MZAIK'S RIGHT TO FULL AND EFFECTIVE REDRESS AND REPARATION INCLUDES COMPENSATION FOR ANY ECONOMICALLY ASSESSABLE DAMAGE, REHABILITATION, AND SATISFACTION AND RIGHT TO TRUTH.

- 53. Article 14 of CAT requires that a State "ensure in its legal system that the victim of an act of torture obtains redress and has an enforceable right to fair and adequate compensation, including the means for as full rehabilitation as possible."⁷⁴ This section describes the contours of the right to redress and reparation under Article 14 of the CAT and highlights certain key principles governing the award of reparations for violations of the prohibition against torture under the CAT. ⁷⁵
- 54. These key principles include the broad conception of the "victim" of torture to cover any person who has suffered harm because of the torture, including family members of the victim; the importance of tailoring redress to an individual victim's needs and claims; the recognition of both the short-term and long-term effects of torture on victims; and the critical role of judicial determinations on the facts of the victim's case in providing redress.

1) Importance of a Holistic and Victim-Oriented Approach

- 55. The Committee against Torture has clarified that the term "victim" refers to any person who has "individually or collectively suffered harm, including physical or mental injury, emotional suffering, economic loss or substantial impairment of their fundamental rights, through acts or omissions that constitute violations" of the CAT.⁷⁶ This includes "affected immediate family or dependants of the victim as well as persons who have suffered harm in intervening to assist victims or to prevent victimization."⁷⁷ Moreover, a person is a "victim" "regardless of whether the perpetrator of the violation is identified, apprehended, prosecuted or convicted."⁷⁸
- 56. As detailed above in Section III.A., Mr. Mzaik has suffered harm physically, mentally, and emotionally at the hands of agents acting on behalf of Syria in violation of Article 14 of the CAT. Mr. Mzaik is therefore a victim of torture as defined by the Committee against

Torture and is entitled to "full and effective redress" for the harm he has suffered under international law.

- 57. A victim's right to full and effective redress under international law is both procedural and substantive, encompassing "[e]qual and effective access to justice" (or "effective remedy") and "[a]dequate, effective and prompt reparation for harm suffered."⁷⁹
- 58. A victim's participation and opinions should be considered as crucial factors when deciding the scope of redress. The Committee against Torture has emphasized that the "ultimate objective . . . of redress" is the "restoration of the dignity of the victim."⁸⁰ This means that States should adopt an explicitly holistic and victim-orientated approach when providing redress by "tak[ing] into account the specifics of each case" and that redress "should be proportionate to the 'gravity of the violations committed."⁸¹ The remedy provided must, therefore, take into consideration an individual victim's needs and claims.
- 59. Individuals like Mr. Mzaik who have been exposed to torture have suffered serious attacks on their lives, relationships, health, and sense of dignity. The torture they experienced will remain a part of them even if they manage to move ahead and work through the pain. Accordingly, reparative measures for victims of torture should aim to include "holistic and long-term rehabilitation efforts to restore the dignity, physical and mental ability, and social independence of the individuals concerned, as well as their full re-inclusion in society."⁸² Giving voice to and respecting the decisions and agency of torture survivors are vital components of a process of recovering life and dignity and should therefore be included in the redress provided.

2) Adequacy of Compensation

60. Victims have a right to prompt, fair and adequate compensation for torture under Article 14.⁸³ Any compensation awarded must also be "multi-layered . . . and sufficient to compensate for any economically assessable damage resulting from torture or ill-treatment,

*whether pecuniary or non-pecuniary.*⁸⁴ Thus, any compensation awarded to Mr. Mzaik should suffice to compensate him for any economically assessable damage resulting from his torture.

- 61. Importantly, there is no time limit on damage resulting from torture and other ill-treatment. Therefore, any compensation should also account for the fact that torture has both short-term and long-term "emotional, social and cognitive effects."⁸⁵
- 62. Moreover, damage resulting from torture includes not only the pain and suffering of the tortured person, but also of their families and dependents. As noted above, Article 14's definition of "victim" includes immediate family and dependents of torture victims.⁸⁶ The inclusion of immediate family in the definition of victim ensures full and effective redress since torture "affects not only the tortured person but also those confronted with the fact that a loved one is being subjected to or threatened with pain."⁸⁷ Indeed, the torture of a family member "may alter the lives of relatives when the victim returns ... [r]econstructing family life after torture ... can be a long and hard process."⁸⁸
- 63. While the Committee against Torture has not specified criteria for quantifying compensation, it has rejected compensation that was merely "austere and symbolic" and therefore not "fair and adequate" compensation under Article 14.⁸⁹ Thus, any awarded compensation must be more than symbolic and should be sufficient to compensate Mr. Mzaik and his family or dependents with economically assessable damage, suffered both in the past and for the foreseeable future.

3) Satisfaction and the Right to Truth

64. Truth-seeking and accountability help restore the dignity and reputation of victims, and a court's judicial determinations on the facts of a victim's case may therefore be a critical piece of the victim's right to redress.

- 65. The "notion of satisfaction is based on the idea that victims can draw moral reparation and the restoration of a sense of justice from the acknowledgment of their suffering, the acceptance of responsibility by the State, the establishment of the truth (with regard to both the individual victim and his or her family and with regard to the general public), and the punishment of perpetrators."⁹⁰ Satisfaction should include, *inter alia*, (1) "[v]erification of the facts and full and public disclosure of the truth to the extent that such disclosure does not cause further harm or threaten the safety and interests of the victim, the victim's relatives, witnesses, or persons who have intervened to assist the victim or prevent the occurrence of further violations," (2) "[a]n official declaration or a judicial decision restoring the dignity, the reputation and the rights of the victim and of persons closely connected with the victim," (3) "[j]udicial and administrative sanctions against persons liable for the violations" and (4) "[c]ommemorations and tributes to the victims."⁹¹
- 66. Similarly, the right to truth, through judicial process such as this one, ensures that (1) facts of what happened become known; (2) rights can be claimed before an impartial and independent tribunal (required for effective remedy); and (3) that perpetrators are punished with equal severity to the crime committed.
- 67. However, only informing the victim and their family of the truth of what happened is not necessarily sufficient. Rather, the right to truth encompasses more than disclosure of evidence of human rights violations to victims and their families. "It also carries a *collective dimension in relation to society as a whole*: for facts and events of the past to become truth, they must be acknowledged as such by the community or society, and information about them must to that end be widely disseminated."⁹² For example, the Committee against Torture recommended that Japan publicly acknowledge legal responsibility for the crimes of sexual slavery during World War II, stop the repeated denial of the facts by State authorities and public figures, investigate and punish the perpetrators, and educate the public as a preventive measure to ensure the victims' satisfaction and their right to truth.⁹³

- 68. In this case, Mr. Mzaik has explained that his primary motivation for bringing the lawsuit against Syria is to "draw public attention for hundreds of thousands of Syrian[s]... [who] are still detained and tortured in Syria."⁹⁴ In particular, Mr. Mzaik has said that he filed the lawsuit "in the name of all the many Syrians who were tortured in detention centers but who don't have the opportunity to obtain justice." ⁹⁵ In short, truth-seeking and accountability are critical components of Mr. Mzaik's lawsuit.
- 69. Here, the Court may ensure Mr. Mzaik's satisfaction and right to truth by making judicial determinations on Mr. Mzaik's case and the broader pattern of torture perpetrated by Syria, recognizing the harm suffered by Mr. Mzaik, his family, and other victims of torture at the hands of Syria, and awarding appropriate punitive damages to deter Syria's torture practices.

IV. CONCLUSION

- 70. Syrian officials' maltreatment of Mr. Mzaik constitutes torture under the CAT, as confirmed by the definition of torture in Article 1 of the CAT and the decisions of the Committee against Torture and other international and regional human rights bodies, and consistent with the findings of the UN Syria Commission of Inquiry and numerous human rights organizations.
- 71. Under international law, as a victim of torture, Mr. Mzaik is entitled to full and effective remedy and reparation. This requires a holistic and victim-oriented approach that takes into consideration Mr. Mzaik's individual circumstances, including his motivation to bring this lawsuit to hold Syria accountable for and deter its arbitrary detention and torture practices.
