| The Court has carefully reviewed the evidence presen | ted and is satisfied that the motion should be |
| granted. | |
| The Court finds that: | |

- 1. The undersigned judicial officer is authorized under Title 18, United States Code, Section 3184, to conduct an extradition hearing.
- 2. The Court has personal jurisdiction over the fugitive Montano Morales and subject matter jurisdiction over this proceeding.
- 3. There is currently in force an extradition treaty between the Government of the United States and the Government of the Republic of Spain. The 2004 U.S.-Spain Extradition Instrument entered into force on February 1, 2010.

- 4. Montano Morales is wanted by the Spanish authorities so that he can prosecuted for the terrorist murder of five Jesuit priests (who were Spanish nationals) under Articles 174bis and 406 of the Spanish Penal Code of 1973 (now codified at Articles 572.1 and 139, respectively, of the Spanish Penal Code of 1995). An order for Montano Morales's arrest was issued in Spain on March 31, 2011.
- 5. These charges are encompassed by Article II of the extradition treaty because they are punishable under the laws of the United States and Spain by a term of imprisonment which exceeds one year.
- 6. Spain seeks the extradition of Montano Morales so that he can stand trial for these offenses.
- 7. There is probable cause to believe that Montano Morales, the same person who is before this Court, participated in the murders for which his extradition is sought.

Based on the foregoing findings, the Court concludes that Inocente Orlando Montano Morales is subject to extradition and surrender to Spain for the terrorist murders of Father Ignacio Martin Baro, Father Segundo Montes Mozo, Father Armando Lopez Quintana, Father Juan Ramon Moreno, and Father Ignacio Ellacuria Beascoechea, and hereby certifies this finding to the Secretary of State as required under Title 18, United States Code, Section 3184.

IT IS THEREFORE ORDERED that a certified copy of this Certification of Extradition and Order of Commitment be forwarded without delay by the Clerk to the Department of State, to the attention of the Office of the Legal Adviser;

AND IT IS FURTHER ORDERED that Inocente Orlando Montano Morales be committed to the custody of the United States Marshal pending final disposition of this matter by the Secretary of State and surrender to designated agents of the Government of Spain.
