12/19/2022	180	<p>Judge Allison D. Burroughs: ELECTRONIC ORDER entered. Plaintiffs have moved for the entry of a protective order pursuant to Fed. R. Civ. P. 26(c). Having reviewed the moving papers, including the memorandum in support of the motion, the declaration of Juders Ysem, the declaration of Bonnie Lau, and supporting exhibits, the Court concludes that Plaintiffs reasonably fear for their safety and the safety of witnesses who may testify at the trial in this matter that is scheduled to begin on March 13, 2023. Their fears are based on past dealings with Defendant as well as threats made against them during a recent meeting that was purportedly convened by Defendant's brother, Faria Viliena.</p> <p>Based on these submissions, the Court concludes that Plaintiffs have demonstrated good cause for a protective order, and it is HEREBY ORDERED that:</p> <p style="padding-left: 40px;">(1) Jean Morose Viliena shall not engage in any actions, either directly or indirectly, designed to intimidate, harass, or physically harm Plaintiffs, their families, or any potential witnesses who may testify at the trial in this matter or the families of those witnesses; and</p> <p style="padding-left: 40px;">(2) Any violation of this Protective Order may result in sanctions.</p> <p>(Currie, Haley) (Entered: 12/19/2022)</p>
