ANSWER TO COMPLAINT, DENYING ALLEGATIONS OF TORTURE; ATTEMPTED EXTRAJUDICIAL KILLING; CRUEL, INHUMAN OR DEGRADING TREATMENT OR PUNISHMENT; ARBITRARY DETENTION; CRIMES AGAINST HUMANITY; AND WAR CRIMES [JURY TRIAL DEMANDED]

COMES NOW, before this Honorable Court, your defendant in respect of the above–encaptioned cause, *viz.*, YUSUF ABDI ALI, by and through his undersigned attorney and counsellor, *viz.*, Joseph Peter Drennan, and herewith answers the Complaint against him, alleging, *inter alia;* torture; attempted extra–judicial killing; cruel, inhuman or degrading treatment or punishment; arbitrary detention; crimes against humanity; and war crimes, completely and unequivocally, and further admits or denies the the discrete, specific allegations of the Complaint, and, further, states certain affirmative defenses, as follows, *viz.*:

AS AND FOR A FIFTH AFFIRMATIVE DEFENSE

149. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the doctrine of issue preclusion;

AS AND FOR A SIXTH AFFIRMATIVE DEFENSE

150. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the doctrine of *res judica*;

AS AND FOR A SEVENTH AFFIRMATIVE DEFENSE

151. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the non–justiciability of issues relating to the control and governance of Somalia, which matters are the sole domain of the Executive Branch, under the Constitution of the United States of America;

AS AND FOR A EIGHTH AFFIRMATIVE DEFENSE

152. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the plaintiffs' unclean hands;

AS AND FOR A NINTH AFFIRMATIVE DEFENSE

153. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the equitable doctrine of estoppel by conduct;

AS AND FOR A TENTH AFFIRMATIVE DEFENSE

154. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the equitable doctrine of estoppel by representation;

AS AND FOR A ELEVENTH AFFIRMATIVE DEFENSE

155. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the equitable doctrine of estoppel by conduct;

AS AND FOR A TWELFTH AFFIRMATIVE DEFENSE

156. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the equitable doctrine of estoppel by silence;

AS AND FOR A THIRTEENTH AFFIRMATIVE DEFENSE

157. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the equitable doctrine of estoppel *in pais*, also known as quasi-estoppel;

AS AND FOR A FOURTEENTH AFFIRMATIVE DEFENSE

158. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the equitable doctrine of waiver;

AS AND FOR A FIFTEENTH AFFIRMATIVE DEFENSE

159. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the doctrine of *forum non conveniens*.

AS AND FOR A SIXTEENTH AFFIRMATIVE DEFENSE

160. In addition to the foregoing affirmative defenses, the Complaint is barred, in whole or in part, because of the ramified grounds set forth in your defendant's *Motion to Dismiss With Prejudice the Complaint*, and the *Memorandum of Points and Authorities in Support* whereof, filed herein on 10 January 2005.

WHEREFORE, having thus fully answered the Complaint, your defendant hereby and herewith demands that the Complaint be dismissed; that he recover his costs hereby expended; and that he be afforded such other and further relief as this Honorable Court may deem just and fitting.
