**CLARIFIED ORDER AUTHORIZING AND DIRECTING NORTHERN TRUST TO
PAY FUNDS HELD IN ESCROW TO HOLLAND & KNIGHT LLP, IN TRUST FOR
PLAINTIFF AND JUDGMENT CREDITOR MARIE JEANNE JEAN**

This cause having come to be heard upon Marie Jeanne Jean's Agreed Motion for Clarified Order Authorizing and Directing Northern Trust to Pay the Balance on Deposit in the Court's Escrow Account to Holland & Knight LLP, in Trust for Marie Jeanne Jean, and the Court having reviewed the motion, it is hereby,

ORDERED AND ADJUDGED:

1. Subject to paragraph 2 below, Northern Trust, N.A., f/k/a Northern Trust Bank of Florida, N.A. ("Northern Trust") shall pay, within five (5) days of receipt of a certified copy of this executed order, the principal sum of \$866,219.33 together with all accrued interest thereon, being the balance currently on deposit in that money market account titled in the name of Lump Sum Capital, LLC, Account No. 2710002394 with Northern Trust, at 2300 Weston Road, Weston, FL 33326, established pursuant to this Court's Amended Order of September 21, 2004, a copy of which is attached as Exhibit A to this Order, to Holland & Knight LLP in trust for




Marie Jeanne Jean, to the attention of Dwayne Williams, Esq., 701 Brickell Avenue, Suite 3000, Miami, Florida 33131. Upon delivery of the aforesaid sum, Northern Trust shall be relieved of all further responsibility for this account or the October 14, 2004 Writ of Garnishment issued in this case.


2. The aforesaid payment to Jean shall be in partial satisfaction of Dorélien's liability to Jean pursuant to the Judgment of the Court of First Instance of Gonaïves, Haiti, rendered November 16, 2000, attached as Exhibit B, which was recognized as an enforceable judgment in Florida, by the Court's Order Recognizing Foreign Judgment, rendered December 3, 2004, attached as Exhibit C.

3. Northern Trust may withhold the sum of \$1,000.00 from the escrow account, in full and final satisfaction of its attorneys' fees and costs incurred in connection with the garnishment and its response to Jean's motion.
