

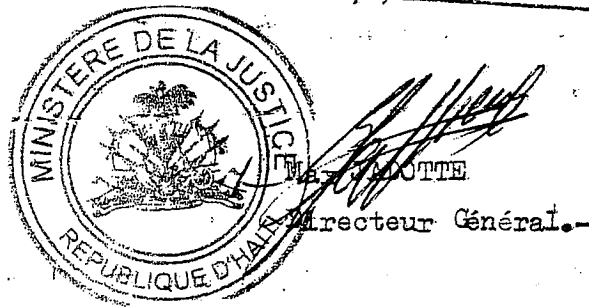

I, **RAOUL JACQUES**, Senior Clerk of the Court of First Instance of Gonaives, hereby certify and attest that: in compliance with the Court Order pronounced by the Supreme Court of the Republic on Tuesday May Third 2005 which voided the order of reference of 30 August 1999, pertaining to the "Massacre of Raboteau" and that of the Senior Judge of the Court of First Instance of Gonaives rendered on May Thirty-First 2005; confirming the annulment of the Judgment in absentia rendered on November 16th 2000; **NO CHARGES** have been held against Mr. **CARL DORELIN**, an ex member of the Staff of Superior Officers of the Armed Forces of Haiti, in the case Known as "Massacre of **RABOTEAU**" in Gonaives.
