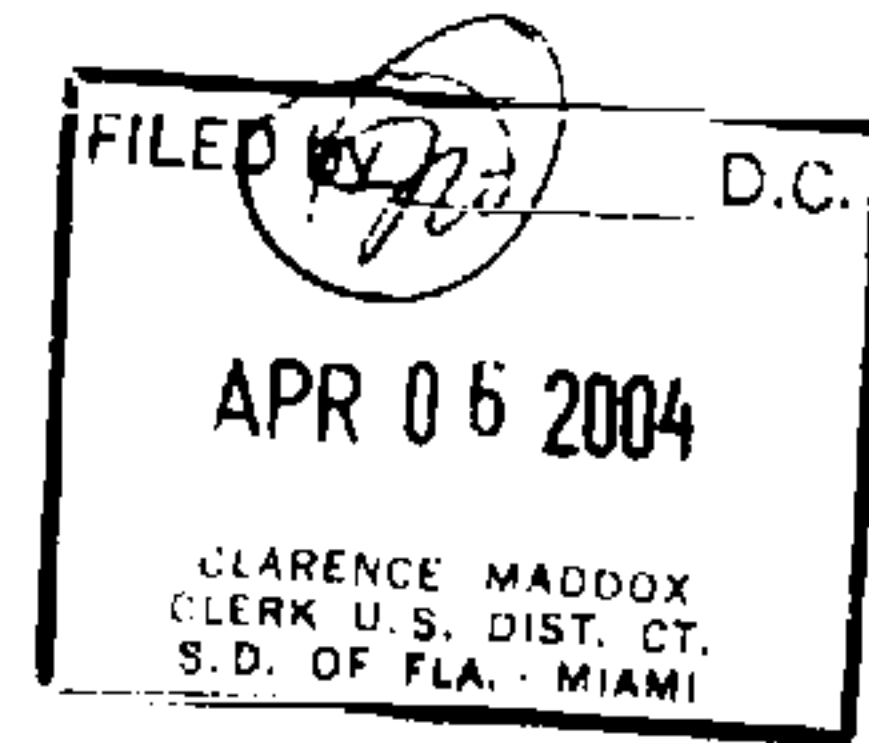


**FINAL JUDGMENT**
