RESPONSE TO PLAINTIFFS' MOTION FOR JUDICIAL NOTICE

Defendant Mohamed Ali Samantar ("Samantar") opposes the motion of Plaintiffs that the Court take judicial notice of certain alleged facts. First, Plaintiffs could and should have presented all of these assertions to the district court below, and they may not be introduced into the record for the first time on appeal. Moreover, nearly all of the assertions offered by the Plaintiffs for judicial notice, including most of those on which Plaintiffs rely in their opening Brief,

constitute contestable allegations rather than indisputable facts and are, accordingly, inappropriate for judicial notice.

I. The Record of this Case is Closed to the Assertions Proffered by Plaintiffs.

An appeal is a review of a decision of a district court, and "an appellate court normally will not consider facts outside the record on appeal." *Colonial Penn Ins. Co. v. Coil*, 887 F.2d 1236, 1239 (4th Cir. 1989). In refusing to consider for the first time on appeal certain medical journals and public health publications, this Court stated that "we will not consider factual evidence that was not presented at trial." *Montalvo v. Radcliffe*, 167 F.3d 873, 878 (4th Cir. 1999); *see Deutser v. Marlboro Shirt Co.*, 81 F.2d 139, 143 (4th Cir. 1936).

All of the alleged facts presented for judicial notice by Plaintiffs to this

Court could have been presented to the district court below for judicial notice.

This case was pending before the district court for almost three years and was

twice the subject of full briefings and hearings on motions by Defendant Samantar

to dismiss. Plaintiffs had ample opportunity to request supplementation of the

district court record with the assertions they now press for judicial notice upon this

¹ While some of the proffered assertions appear in sources that postdate the district court's opinion, Plaintiffs do not allege that these assertions are new and do not appear in predecessor sources.

Court. Plaintiffs provide no explanation as to why they did not present these alleged facts below.² See Causey v. Balog, 162 F.3d 795, 803 n.5 (4th Cir. 1998) (evidence may not be considered on appeal if it could have been but was not offered to the district court and "no legitimate reason" is provided for the omission).

II. The Assertions Urged by Plaintiffs do not Qualify for Judicial Notice in that They are not Indisputable.

Numerous of Plaintiffs' alleged facts are not even eligible for admission by judicial notice in that they clearly are disputable. The Federal Rules of Evidence provide that "A judicially noticed fact must be one not subject to reasonable dispute" Fed. R. Evid. 201(b). "Only indisputable facts are susceptible to judicial notice." *Nolte v. Capital One Fin. Corp.*, 390 F.3d 311, 317 n. (4th Cir. 2004) (citations omitted); *see United States v. Jones*, 29 F.3d 1549, 1553 (11th Cir. 1994) ("the fact must be one that only an unreasonable person would insist on

² An apparent reason for Plaintiffs' first offering these alleged facts on appeal is that they are to be used in support of an argument that Plaintiffs did not make to the district court and wrongfully seek to make for the first time on appeal, *viz.*, that, because of alleged unrest in Somalia, the country does not qualify as a "Foreign State" under the Foreign Sovereign Immunity Act (28 U.S. C. §§ 1608-11). *See* Plaintiffs' Brief at 21 (citations to alleged facts proposed for judicial notice).

disputing"). Indeed, several of the "facts" are disputed within the very documents that Plaintiffs attach to their motion as the sources of their alleged facts.

Thus, Plaintiffs assert that: "The Transitional Federal Government ("TGF") formed in 2004 has never had a defined territory or population under control, nor does it govern the autonomous areas that make up Somaliland or Puntland'..." Motion at ¶ 1. These contentions are contradicted in both the "Background Note: Somalia," issued by the U.S. Department of State and in the World Factbook issued by the Central Intelligence Agency ("CIA") attached to Plaintiffs' motion as Exhibits A and C, respectively. Both publications set out a map of Somalia with defined boundaries no different from the boundaries that obtained when Defendant was Prime Minister, and both documents refer to the Transitional Federal Government as the governing authority of that territory. Motion, Exhibit A, at 1-2; Motion, Exhibit C, at 1, 5.

Similarly, Plaintiffs assert that Somaliland and Puntland are "autonomous." Motion at ¶ 1. The Department of State reports that: "Two regional administrations exist in northern Somalia—the self-declared 'Republic of Somaliland' in the northwest and the semi-autonomous region of Puntland in the northeast." Motion, Exhibit A, at 7. The CIA document contains similar language. Motion, Exhibit C, at 6. The State Department and the CIA,

accordingly, dispute that these regions are "autonomous" as the Plaintiffs would have this Court find to be indisputable fact.

Finally, Plaintiffs assert that "the U.S. Government does not officially recognize a government in Somalia and has no official presence in the former Somalia or Somaliland." Motion at ¶ 2. Leaving aside Plaintiffs' reference to a "former Somalia" or to a "Somaliland," both contentious issues that are discussed above, Plaintiffs' blanket assertion of the absence of U.S. Government recognition or presence is belied, or at least strongly qualified, by a number of statements in Plaintiffs' own sources. Hence, the State Department, in its Background Note, affirms that the United States has never severed diplomatic relations with Somalia and that it "maintains regular dialogue with the Transitional Federal Government ... through the U.S. Embassy in Nairobi, Kenya." Motion, Exhibit A, at 9. Moreover, Plaintiffs' Exhibit E comprises a transcript of an interview with the U.S. Special Envoy to Somalia who describes not only supervising a Somali unit within the U.S. Embassy in Nairobi but also traveling to Somalia to meet with the Somali prime minister and to speak with the Somali parliament. Motion, Exhibit E, at 1-2. In fact, contrary to Plaintiffs' assertions, the State Department does recognize Somalia as an independent state and maintains diplomatic relations

with Somalia. U.S. Dep't of State, Bureau of Intelligence and Research,

attached hereto as Exhibit A.

Because all of the assertions submitted by Plaintiffs for judicial notice could and should have been presented to the district court below and numerous, if not all, of them are subject to reasonable dispute, Defendant Samantar maintains that they cannot be noticed judicially by this Court. Accordingly, Defendant Samantar
